ST341 Valuable conversations for reducing the impact of alcohol use in child-bearing years

Presented by: Community Support and Development Programs, Mental Health Commission. Date: 19-20 June 2024 • 9.00am - 4.30pm

ST284 Motivational Interviewing – Part 1

Motivational interviewing (MI) is an established person-centred, evidence-based practice for AOD treatment. Participants will be introduced to the theoretical framework of MI and will learn skills aimed at developing a collaborative 'change conversation' that will help people to identify and examine their ambivalence around AOD use.
