Webinar Event 1: An introduction to grounding

Target audience: Human service providers working with clients who use AOD.

Grounding is a technique that can be used to help distract clients from negative thoughts and feelings by guiding them to focus on the external world. Many clients with alcohol and other drug (AOD) issues have high levels of distress and trauma, and grounding techniques can be a fundamental approach to help our clients manage their distress. This webinar will introduce participants to grounding strategies. At the end of the session participants will have an understanding of when grounding may be beneficial and various strategies to help clients to ground themselves.

Webinar Event 2: Prescription medication use problems

Target audience: Clinicians working with patients prescribed psychoactive substances.

As non-therapeutic psychoactive prescription medication use issues have grown in Australia, together with prescription opioid overdose deaths, several jurisdictions have introduced prescription monitoring programs. Western Australia (WA) will introduce such a program in 2022.

This presentation will provide an overview of the use of prescription-only drugs for non-therapeutic purposes, together with the prescription monitoring system that will commence this year in WA and how this will impact on consumers and practitioners.

This training will cover:

- Trends in the use of prescription medications
- Prescription monitoring systems and the impact on patient-doctor interactions.
- How will GPs respond when the program informs them the patient is being prescribed psychoactive medication from multiple prescribers or in amounts that can cause harms?

Webinar Event 4: Using technology to provide counselling

As a result of COVID-19 many workers have had to rely on technology to engage with clients. For some agencies, providing services using technology has now become a complementary means of providing counselling. E-therapy has many benefits, including increasing access for people with transport and mobility issues and people who live regionally or remotely.

Despite the benefits of e-therapy, counsellors can feel uncomfortable using technology to provide counselling. This webinar explores strategies for effective e-therapy with a focus on telephone and web-based counselling.

Webinar Event 5: An introduction to coercive control

Coercive Control is identified as the 'Golden Thread' of Family and Domestic Violence (FDV) and is necessary to understand for anyone who works with clients who are experiencing FDV. In collaboration with Women and Newborn Services, this brief and intensive webinar is an abridged 2-hour version which covers:

- Prevalence of FDV within Australia and WA
- Origins of Coercive Control conceptually
- Elements of Coercive Control
- Current laws around Coercive Control
- Health effects of FDV on victims/survivors
- Risk Assessments
- Responding to Disclosures of FDV
- Trauma informed intervention methods
- Key contacts for further assistance for both practitioner and victim/survivor
- New directions in FDV

Webinar Event 6: Worker self-care in the time of COVID
