# Lived Experience Consumer member for the

## **Mental Health Executive Committee and**

## **Community Mental Health Alcohol and Other Drug Council**

Involving all stakeholders in the Mental Health Commission's (MHC) work is essential if improvements in mental health, alcohol and other drug (AOD) outcomes are to be achieved. The MHC recognises the valuable contribution that consumers, family members, significant others and community members make to the planning, implementation, delivery and evaluation of mental health and AOD programs and services.

Key governance mechanisms were established in March 2020 following the release of the Review of the Clinical Governance of Public Mental Health Services in Western Australia, to ensure system partners continue to provide shared leadership to deliver key system priorities. The Mental Health Executive Committee (MHEC) and Community Mental Health, Alcohol and Other Drug Council (CMC) are key mechanisms to oversee and drive system transformation.

The MHEC and the CMC are accountable for the successful implementation of the system-wide reform initiatives and their role is to strengthen integration and accountability across the mental health and AOD system. The MHEC and CMC focus on improving partnerships and person-centred care, within hospital and community settings, to ensure that lived experience is central to policy development and service delivery. The MHC, on behalf of the Committees, is seeking expressions of interest to appoint **one consumer member** to the MHEC and CMC.

#### **The Committee**

Duration of appointment: 2 years with the possibility of renewal, maximum of two terms.

#### **Payment**

Depending on the length of the meeting, additional hours may be paid to support meeting preparation. Additional guidance on this is provided in the Policy.

### Selection criteria/questions

- 1. Demonstrated experience in high level governance positions
- 2. Demonstrated strategic thinking skills
- 3. Demonstrated Lived or Living Experience in mental health and/or alcohol and other drug issues
- 4. Demonstrated ability to apply and contribute a collective Lived Experience perspective to strategic decision making.
- 5. General understanding of the WA mental health, alcohol and other drug, and suicide prevention sector, including the primary, secondary and tertiary care mental health systems.
- 6. General understanding of the priority reform areas regarding the WA mental health and AOD service system and the levers of change to support system transformation
- 7. Residential address within Western Australia and ability to attend most meetings in-person.
